Old Business

- i. Attorney Response
 - 1. Latent Powers
 - The CSD is limited to its active powers, but it can go to LAFCO to activate latent powers.
 - 2. Joint Workshop with HOA Board
 - CSD counsel recommended limiting joint meetings to nonaction items (although legally not required) and agendizing action items for a separate board meeting for specific actions. This avoids confusion and gives some time for public input. It also helps avoid unintentional Brown Act violations because you can't always predict which actions might be taken after a brainstorming session.

Alternatively, the CSD could designate a Board subcommittee to workshop ideas with a subcommittee of the HOA Board as well. As long as it is properly set up as an ad hoc (not standing) committee, those meetings would not need to be agendized. *Full response on file at CSD office*.

Terry Schutten did not agree. He felt it could be done in a workshop setting as long as no action was taken and the agenda was set.

Bob Vance recommended the CSD create its own subcommittee and was not in favor of co-mingling the two groups.

The Board discussed the pros and cons of holding a joint meeting.

Motion: Dan Schmidt motioned the CSD President inform the HOA President that the CSD would like to see some sort timeline, and/or capital improvement plan, before having a joint meeting to see what items the CSD can and assist the HOA with. Second by Terry Schutten.

Discussion: Bob Vance recommended a conference call with the CSD attorney prior to making a decision on a joint meeting.
