4. GREENSTONE COUNTRY CSD

i. Survey

Purpose of the survey

 Rod Rozman felt the purpose should be to get meaningful results the Board could act on. Enough information should be included in each question to achieve detailed results. He also felt the Board should pick a number as a goal, for example, 60-70 percent affirmative on a particular question before proceeding on an issue.

Bob Vance did not think the survey should dictate what the Board is going to do. The Board has the responsibility to consider all factors and take action accordingly. The survey is just a simple tool to find out what some folks in the CSD are thinking. If only a small number of residents respond to the survey, those results should not trigger action by the Board.

The Board discussed the value of conducting a survey. Terry Schutten commented if there will be no action based on the survey results, why is the CSD conducting one?

Bob Vance was concerned about governing by survey. The CSD has specific powers and knows what it is supposed to do.

Terry Schutten recommended tabling the survey.

Dan Schmidt agreed stating the Board first needs to know what it wants out of the survey. We don't know what we will get out of this except for some people's opinions, but what does the Board really want? And, if the Board wants something specific, we need to ask some questions and say what is it going to cost us. You need to know what you are trying to get out of the survey.

Motion: Terry Schutten motioned to table the survey to a future time when the CSD has a particular item it wants to ask the community about. Second by Bob Vance.

Discussion: The Board discussed a variety of scenarios where a survey would be helpful. The consensus of the group was the CSD should identify what areas or priorities it wants to focus on, as well as work on branding for the CSD.
