4. CSD GEOLOGIST REPORT

5. GREENSTONE COUNTRY CSD

- Old Business
 - Capital Improvement Plan requested from HOA
 - HOA President Dave Mosakewicz discussed the plan he provided to the CSD related to culverts. The cost over five years is in the range of \$280,000. Rod Rozman requested a proposal that is approved by the HOA board so those numbers can be included in the HOA's annual budget request to the CSD.
 - Terry Schutten added that the proposal should include a timeline to insure the work is done within a specified timeframe.
 - The HOA will provide a plan to the CSD by April 1, 2020.
 - Joint Workshop with HOA Board
 - The Board discussed weather to hold a joint workshop based on comments from CSD legal counsel. Terry Schutten did not agree with the attorney's proposed guidelines/restrictions for a joint workshop.
 - The Board ultimately decided a joint workshop was not

necessary if the HOA provides a detailed capital improvement plan specific to CSD funding.

- Firewise Communities
 - The HOA is looking into setting up a Firewise Communities Chapter for Greenstone Country.
- Response from CSD attorney on inspection non-compliance
 - CSD counsel advised that an inspection warrant would be required to access a property that has not complied with the CSD's inspection ordinance. An abatement warrant could be obtained in an urgent situation such as a failed system.
 - The Board decide to wait and see what alternatives the County could offer before having the attorney draft a final notice.
- · Septic Policy
 - Contractor for policy development

Greg Smith discussed the sample policy from Auburn Lakes Trails. Greg said he would work on something more detailed related to owner responsibility and pumping requirements before giving a recommendation on whether or not to hire a contractor to draft a more comprehensive policy.

Shelly recommended updating the ordinance as well.

New Business

- Meeting with County Environmental Management
 - Inspection contract
 - Bob Vance and Shelly Greene met with Bryan Vyverberg, Supervising Environmental Health Specialist for El Dorado County, to discuss the possibility of the County doing the annual septic inspections for Greenstone Country. Mr. Vyverberg will discuss with his Director.
 - Bob Vance discussed the current voucher program and suggested the 90 day window to use the voucher be reduced.
 - Motion: Greg Smith motioned to reduce the window to use the pumping voucher to 30 days.

Discussion: Terry asked Shelly to research if a resolution is required.

Motioned tabled to next meeting.
