- Septic Policy

Greg Smith reviewed the proposed septic policy.

Bob Vance recommended adding language from Ordinance 81-1 that requires septic repairs to be done within 30 days of notification by the CSD.

Shelly will have CSD attorney review policy and ordinance to ensure the two do not conflict.

- 24” Riser Installation

Greg Smith gave a slide presentation demonstrating how he installed 24” risers on his septic tank. He proposed putting a link on the CSD website with installation instructions for residents wishing to do their own installation.

Greg will finetune the slideshow and return to Shelly to post on the website. Shelly will also post a convenience list of contractors on the website.

- Security

- i. Discussion with HOA Security Committee

Rod Rozman reminded the group that he met with the HOA Security Committee, and they discussed upgrading security cameras and installing license plate readers. The committee agreed the security patrols currently in place were not effective.

- ii. Security Camera’s

EJ Fontaine of the HOA Security Committee gave a historical overview of the current security camera system, which he feels is failing. A new plug and play system with license readers would be approximately \$35K. The recommendation is to move funds from the security patrols and put those funds towards new cameras.

Rod asked EJ to get agreement from the HOA board and come back to the CSD with an update.
