## 3. GREENSTONE COUNTRY CSD

#### ITEMS FOR DISCUSSION

- i. Letter from HOA
  - 1. Rod Rozman read a letter presented to the CSD by the HOA requesting that the CSD not increase the Special Tax until the HOA completes its budget cycle.

Bob Vance commented the CSD, as a public agency, needs to be cautious of comingling budgets with the HOA.

The HOA Vice President commented the letter is an effort to work collaboratively with the CSD not comingle budgets.

- ii. Resolution 2019-03, to Adjust/Increase District Special Tax (*PowerPoint available for viewing at CSD office*.)
  - 1. Rod Rozman explained to the group that after review by CSD counsel, Resolutions 2019-03 and 2019-04 we consolidated into one resolution (2019-03).
  - 2. Bob Vance presented an overview of Resolution 2019-03, with options A, B &C.

Rod Rozman felt the statement in the resolution "WHEREAS, an adjustment in the Special Tax rate is necessary to continue to fund the culvert operations and maintenance efforts and other District services" was not accurate and not necessary.

Terry Schutten interjected there should be a motion on the floor before discussions.

Bob Vance motioned to accept the terms of Resolution 2019-03, option B, to increase the special tax to \$200 for improved lots and \$100 for unimproved lots. No second; motion failed.

Terry Schutten motioned to accept Resolution 2019-03, option A, to increase the special tax by the current CPI of 1.9%. Second by Dan Schmidt; motion carried.

Terry Schutten also motioned to table Resolution 2019-03, options B&C until June 1<sup>st</sup> of next year at which time both options will be reviewed and reconsidered. Second by Dan Schmidt; motion carried.
